4. Description of Vehicles (Make [Ford], Model [Explorer], Color, License Plate)

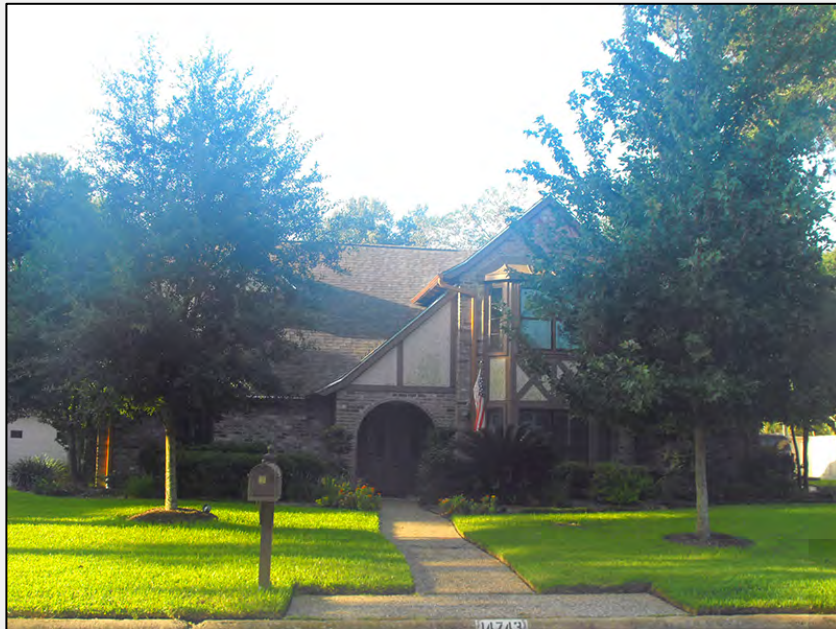

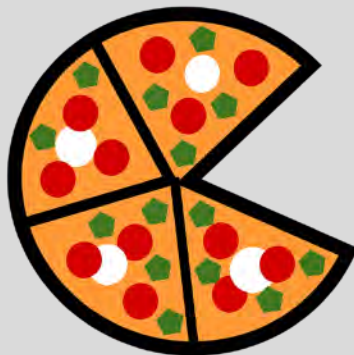
